They are continually putting forward ideas and ways to improve our club and we need to listen to them and be proactive as well.


All members need to think clearly now and be prepared to pencil your name in for the Board positions of 2018/2019.

Constitution is now up to scratch



ASSOCIATIONS INCORPORATION ACT 2015 LIONS CLUB OF MANDURAH (the Association)

I refer to the Notice of committee's resolution to change rules received by this office on 13 September 2017.

The changes have been lodged effective 12 October 2017 and placed on our records on the basis that the Association's executive or committee have declared that the amended rules were passed by their resolution and do no more than give effect to a requirement, restriction or prohibition imposed under the Associations Incorporation Act 2015 (the Act). Lodgement should not be taken as validation that the rules conform to the requirements of the Act.

Please ensure that these changes are sent to members along with notice of the next annual general meeting.

It is important to be aware that if the rules do not meet the Scheduled requirements or are inconsistent with the $A\alpha$, those provisions of will be deemed invalid. The parts of the Prescribed Model Rules that deals with those matters will continue to apply as the Association's rules from 1 July 2019.

As you will appreciate the process of applying the Prescribed Model Rule(s) has the potential to be confusing for members. It may also lead members to make decisions based on incorrect requirements. In light of this, the Association is strongly encouraged to conduct its own examination of its rules to ensure they address the mandatory requirements set out in the Act.

The Department of Mines, Industry Regulation and Safety—Consumer Protection Division (Consumer Protection) has developed the *Associations Transition Pack* 3 which includes a checklist of requirements which can be used as a guide to assist the Association to comply with its obligations under the Act. This Associations Transition Pack 3 is available online at http://www.commerce.wea.gov.au/publications/associations-transition-pack-3

If you find that the rules are non-compliant you must take steps to amend the rules at the next available opportunity. Further information about how to amend the rules of the Association can be found in the Department's Inc - A Guide for Incorporated Associations available online from www.commerce.wa.gov.au/associationsguide/.

Consumer Protection undertakes random audit reviews of revised rules with regard to the matters set out in Schedule 1 but this is not conducted for every lodgement. The Association will be contacted should any problems be identified in the event that a review is undertaken.

It is also opportune to remind the Association that under the Act there is now the requirement to submit an Information Statement (the Statement) to Consumer Protection. The Statement is required to be lodged no later than six months after the end of the association's end of financial year. The Statement can be submitted either by using AssociationsOnline (www.commerce.we.gov.au/associationsonline) or by obtaining and completing the form from the fees, forms and online transactions page of our website (www.commerce.we.gov.au/associations).
